The Board of Commissioners and staff at Metro West Housing Solutions wishes to convey our appreciation to all community supporters and champions of affordable housing who made another great year possible.

2018 was a banner year for Metro West Housing Solutions. In September, the agency was awarded competitive tax credits MWHS Board of Commissioners. George Valuck; for Sage Corner, a planned 43-unit community. Design teams, architects, and construction crews continued their progress on Indy Street Flats, a new community that will add 115 more units of affordable housing to Lakewood when it opens in 2019. In October, MWHS' Board, staff, and the City of Lakewood celebrated the grand opening of Fifty Eight Hundred, providing 152 high quality attainable and affordable apartments to those in Lakewood who need them most.
